One form per anticipated transhipment

This template should be used (as far as practicable) to notify the Secretariat at least 7 days in advance of a 14 day period in which transhipments of *Trachurus Murphyi* or demersal species (caught in the Convention Area) are scheduled to occur, regardless of where the transhipment takes place. The competent authorities of the receiving vessel are responsible for the notification, although they may authorise the vessel operator to provide notification directly.

The competent authorities of both the unloading and receiving vessels should also use this template to notify the Secretariat at least 12 hours before the estimated time of the transhipment, although they may authorise the vessel operator to provide this notification directly.
