Dear Mr. Brown:

I am writing to you in reference to the 14th Annual Meeting of the South Pacific Regional Fisheries Management Organization (SPRFMO), to be held in Panama from February 24 to March 6, 2026.

In light of the above, I would like to inform you that we have made the necessary inquiries regarding the visas required for the members of the Commission to attend this meeting, and the National Immigration Service has informed us that the delegations that need a visa to enter Panama are those listed below:

- Republic of Cuba.
- People's Republic of China.
- Republic of Liberia.

The procedure for applying for a visa for each country is as follows:

Republic of China	The participant must go to the Panamanian Embassy or any of our Consulates in the People's Republic of China, with all the requirements to apply for the visa.
