Potential Hosting for Future SPRFMO Meetings

Secretariat

1. Summary and recommendations

This paper reports on past hosting, and future hosting commitments, of SPRFMO meetings to support the planning of future meetings.

The FAC is invited to:

- **Note** that the next meetings without an offer to host are in 2027 (annual meeting) and 2028 (Scientific Committee).
- **Encourage** Members and CNCPs to consider the feasibility of hosting forthcoming meetings of the Commission, Scientific Committee and workshops.

2. Background

SPRFMO Rule of Procedure 3.1 states that “*Before the end of each annual meeting, the Commission shall, if possible, decide on the date and location of the next annual meeting*”. The Commission also considers forthcoming meetings of the Scientific Committee (SC) and workshops.

This paper scopes potential meeting hosts for the next three years. It does not entail a formal commitment unless confirmation is given by the respective Member or CNCP and endorsed by the Commission. Each meeting is therefore open to more than one Member/CNCP to offer hosting.

The Secretariat is available to provide further guidance on the practicalities of hosting. Members and CNCPs are reminded that, unless otherwise decided by the SPRFMO Commission, all the costs associated with hosting a meeting are to be covered by the host delegation. The Organisation may for example be able to contribute from the Spanish Interpretation Fund.

3. Annual Meetings

The Republic of Korea has offered to host the annual meeting in 2028. Hosting offers are therefore sought for the 2027 and 2029 annual meetings (Table 1).
