# Monitoring of Additional Secretariat's Tasks as per COMM 7 Decisions Secretariat

## 1. Background


At the 7<sup>th</sup> Commission meeting in 2019, the Commission amended 10 Conservation and Management Measures (CMMs), adopted 4 new CMMs, the first SPRFMO Performance Review was discussed, the international cooperation was enhanced and relevant changes from an Administrative point of view, like the adoption and tendering of the Observer Programme, were adopted.

Following these Commission (and subsidiary bodies) decisions, the Secretariat was required to take on substantial additional obligations. In order to facilitate the Commission's discussions, the Secretariat wish to provide a monitoring on the extra workload associated to the additional tasks that the Secretariat took onboard after the finalization of COMM7.

### 2. Task Monitoring

The analysis of the thirty (30) new tasks for the Secretariat, shows an additional workload after COMM7 that should be considered by the Commission when aligning the Secretariat tasks, mandate and the current available human resources.

The Secretariat has been able to deliver not only on the recurrent tasks but also in the 30 new tasks (See Annex 1) where many of them required considering overtime overstretching the capabilities of the Secretariat in order to timely deliver. The figure below shows that 27 out of the 30 additional tasks have been already implemented and three are still ongoing.



#### 3. Recommendation

The FAC is invited to consider the interannual workload increase associated to the developments of COMM8 when addressing the budget discussion for Financial Year 2020-2021.
