6. SPRFMO Meetings

- The 7th Compliance and Technical Committee (CTC7) was held on 10-12 February 2020.
- The **7**th **Finance & Administration Committee** (FAC7) met during the eighth Commission Meeting.
- The 8th Commission Meeting (COMM8) was held from 14 to 18 February 2020, in Port Vila, Vanuatu.
- The CTC convened a mid-year Electronic Working Group to discuss COVID19 on 5 June (G78-2020).
- The 10th Scientific Committee workshop (SCW10) continuing the discussions of the SPRFMO Deepwater Working Group, met remotely, 29 September-2 October 2020.



- The 8th Meeting of the Scientific Committee (SC8) was held remotely from 3 to 8 October 2020. Because of the limited time available to present and discuss papers, seven pre-SC8 web meetings were held, where a great deal of material was covered before the formal opening of SC8.
- The **Heads of Delegations** convened two meetings (22 October and 27 October 2020) to discuss practical aspects and arrangements for the 9th SPRFMO Annual Meeting.
- The SPRFMO Chairpersons and Vice Chairpersons met on 10 December 2020 to discuss the 9th SPRFMO Annual meeting and to provide guidance to the Secretariat regarding the arrangements for the annual meeting (G164-2020)

7. Cooperation with Other Organisations

In 2020, SPRFMO representatives were invited to attend several meetings relevant to the activities and objectives of SPRFMO. Article 31 of the Convention (Cooperation with Other Organisations) calls for appropriate cooperation with other RFMOs, the FAO and other relevant organisations. The Secretariat coordinates attendance of these meetings by officers, delegates, or staff members, bearing in mind the availability of funds and timing. The following details either meetings (virtual) attended or inputs provided during this year:

- SPRFMO-CCAMLR MoU discussions, particularly around regular exchanges of information and experiences (Acting Executive Secretary)
- Pan-Pacific Fisheries Compliance Network (PPFCN). The PPFCN is a recently formed informal group of RFMO Compliance Officers supported by the International Monitoring, Control, Surveillance (IMCS) Network. The goal of this informal group is to work together towards establishing closer links and better enable networking with other colleagues primarily in the Pacific region who are facing similar compliance challenges in the fight against IUU fishing. The Compliance Manager participated on behalf of SPRFMO in 3 virtual meetings late in 2020 (26 October, 10 and 24 November, and 15 December) that resulted in the establishment of a formal Operational Framework to guide the PPFCN. The Operational framework of the PPFCN is available on the SPRFMO website.
- PEW 2020 Virtual Expert Workshop on Best Practices for Compliance in RFMOs (7-11 September 2020)

 the SPRFMO Chairperson lead the Pacific part of this workshop (supported by the Coordination and Communications Officer), whilst the Acting Executive Secretary and Compliance Manager attended in their individual capacities in the Regional Group sessions.
- SBSTTA 24 briefing on the post-2020 global biodiversity framework the Acting Executive Secretary attended this meeting as an observer to ensure SPRFMO was represented and to experience being an attendee in a large international virtual meeting.
- NOAA-SPRFMO MoU signed in September 2020, to supporting the implementation of MCS measures, including the VMS system, the Observer Programme, data collection and analysis, compliance, and enforcement procedures. The MoU is valid for a period of 5 years beginning 1 July 2020, until 30 June 2025.
- IWC input into A Review of Regional Fisheries Management Organization Efforts in Addressing Cetacean Bycatch: Report to the International Whaling Commission.
- WECAFC input and questionnaire for resuming the work for the Strategic reorientation of the Western Central Atlantic Fishery Commission

SPRFMO Convention in other Languages

The Secretariat signed a Memorandum of Understanding with the RMIT University with the primary objective to translate the SPRFMO Convention into languages other than English. The first activity was carried out in 2020 by the students of the RMIT University Translation and Interpretation programme, supervised by the SPRFMO Secretariat. The first task consists of producing translations of the SPRFMO Convention into two languages: Simplified Chinese and Traditional Chinese (Ref: FAC8-Doc08.1 and FAC8-Doc08.2).



- o The Secretariat has contacted the delegation of the People's Republic of China to review and give their approval regarding the Simplified Chinese translation produced by RMIT University. China has advised that they are satisfied with the result. This translation is available as FAC8-Doc08.1.
- o The Secretariat has also contacted the delegation of Chinese Taipei to review and give their approval regarding the Traditional Chinese translation produced by RMIT University. Chinese Taipei has advised that they are satisfied with the result. This translation is available as FAC8-Doc08.2.
- o Additionally, a Spanish translation of the SPRFMO Convention has also been produced and made available by Chile. This source has been available for several years already and has been used as a reference by Spanish speaking delegations. The Spanish translation is available as FAC8-Doc08.3.

The Secretariat intends to continue to work with RMIT in the framework of this MoU to produce translations of the SPRFMO Convention into other languages.

 The Secretariat is inviting the FAC to allow dissemination of the aforementioned translations as unofficial translations of the SPRFMO Convention to facilitate a wider and deeper understanding and of the work of the Organisation.

10. Fishery Statistics

The Secretariat has received the 2019 Annual Catch Reports from all Commission Members and CNCPs who fished in the SPRFMO Area in accordance with CMM 02-2019 (details are reported in COMM9-Inf01).

The Secretariat has processed 1,144 data files received during the year. A summary of those files is shown in Annex I.

11. Communications Activities and Tasks

This section aims to provide an overview of the Communications actions and activities taken up by the Secretariat during 2020, with a focus on dissemination and outreach.

• SECRETARIAT PREMISES. The inauguration of the Secretariat offices took place on 19 March 2020. Representatives of SPRFMO Members and CNCPs in Wellington and other SPRFMO stakeholders in New Zealand were invited to take part. Attendees included the CCAMLR Chairperson and Ambassador of Spain in New Zealand, the Ambassador of Peru in New Zealand, the New Zealand Commissioner to SPRFMO.



- MEET UPS. Introduction and catch-up meetings with representatives of Members in New Zealand in 2020 include:
 - o The visit of the Secretariat to the residence of the Ambassador of Korea in New Zealand;
 - o The meeting of the Acting Executive Secretary with China Embassy representatives;
 - o One-on-one meetings between the Acting Executive of SPRFMO and the Executive Secretary of CCAMLR in the context of experiences with Virtual Meetings;
 - o Meeting between the Acting Executive Secretary and an United States of America Embassy officer, Mr Phil Mackena;
 - o Introduction of Mr Randy Jenkins, SPRFMO Compliance Manager, to compliance officials from Curacao, Australian, and New Zealand compliance officials.
- COMM 9 MEETING. In the context of the 9th Annual Meeting of SPRFMO, the Secretariat reached out to the Russian Delegation in their capacity as host of the 2021 Annual Meeting to discuss the arrangements for the meeting.
- SPRFMO HEADQUARTERS ARRANGEMENTS. The Acting Executive Secretary held a series of meetings with the delegation of New Zealand in their capacity as hosts of the SPRFMO premises, to discuss headquartering and SPRFMO staff working conditions.
- **NEWSLETTER.** Upon the request of COMM8, the Secretariat made the Newsletter suitable for wider audience dissemination and it is now available on the SPRFMO website.
- VIRTUAL MEETINGS. The Secretariat has tested and acquired a subscription to Microsoft Teams, which has proven to provide an appropriate meeting environment that fit the needs of SPRFMO (fora, channels, security, virtual depository).
- COMPLIANCE. The Secretariat has held several virtual meetings with the authorities of Angola and Curação to provide assistance in terms of IUU Vessel processes and Compliance with SPRFMO CMMs.
- **EFFECTIVE PARTICIPATION.** The Secretariat and the delegation of Cuba have had a virtual meeting to agree on a plan/process to ensure Cuba's effective participation at COMM9, as Cuba is unable to engage in virtual meetings due to technical reasons.
- INTERNAL COMMUNICATION. The Secretariat has put emphasis on keeping official contact details up to date. In 2020, **45** updates of official contacts were received as per Rule 2.2 of the Rules of Procedure.
- At FAC7, the Secretariat asked the Commission to consider making an extra-ordinary budget allocation (NZD \$20,000) into the 2022-2023 budget to fund a focused dissemination and anniversary campaign. The campaign proposal that would be presented by the Secretariat at the 9th Commission Meeting has been deferred to the next Annual Meeting due to the uncertainties related to COVID-19 in the normal activities of the Organisation.
 - o **The FAC is invited to consider this allocation** of funds for SPRFMO material dissemination and promotion.

12.Budget

The budget approved by the Commission for the financial year starting 1 July 20120 and ending 30 June 2021 was NZ\$ 1,365,000.

1. Task Monitoring

At the 8th Commission meeting in 2020, the Commission considered 25 proposals and agreed to amend 10 Conservation and Management Measures (CMMs) and adopted 2 new CMMs.

Following these Commission (and subsidiary bodies) decisions, the Secretariat was required to take on substantial additional tasks. This section (as per <u>FAC7-Doc10.1</u> from last year) monitors the status of the new tasks and the associated Secretariat workload.

The analysis of the <u>twenty-nine (29)</u> new tasks for the Secretariat should be considered by the Commission when aligning the Secretariat workload, mandate, and the current available human resources.
