Statement of Written Down Losses (FR6.4)

Financial Regulation 6.4 provides that "the Executive Secretary may, after full investigation, authorise the writing off of losses of cash, stores, and other assets, provided that a statement of all such amounts written off shall be submitted to the Commission and the auditors with the annual financial statements."

## Belize's Membership status of the convention and historical outstanding member contributions:

During the Annual Meeting (COMMo4) in Valdivia, Chile January 2016, the Depository (New Zealand) informed the Commission that Belize's withdrawal from the Convention became effective 1 May 2016. In accordance with this decision, the total historical amount of NZ\$27 823 owed to SPRFMO by Belize had been deemed uncollectable and written off as a bad debt for Financial Year 2016.

At its fifth annual meeting, held in Adelaide, Australia, in January 2017, the Depositary (New Zealand) provided an update of the status of the Convention (COMM5-Doco9) and reported that the withdrawal of Belize became effective on 1 May 2016. The FAC requested the Secretariat to make further efforts to collect the outstanding amounts from Belize. With its letter 107-2017 sent in August 2017, the Secretariat has again reminded Belize of its outstanding financial obligations towards SPRFMO, but at the date of this document (30 November 2017) has not received any response or payment from Belize.
